Also, **Trustee Hermanek made** the following report:

I am happy to report that the Village and the Telecommunicators Union has agreed on a new Collective Bargaining Agreement. The contract covers the period of December 1, 2011 to November 30, 2015 with pay increases of 2%, 2.25%, 2.75% and 3%. The contract also includes an increase in health insurance premium cost to the employee to 8 ½% of the premium cost starting on December 1, 2012 and 10% of the premium cost on December 1, 2013 at which time they will receive a 1% hike in pay to help offset the increase. There was no additional time off given and as of January 1, 2013 any new hire who wishes to continue their participation in the Village's group health insurance program once they retire will be responsible for 100% of the premium payment. The Village will, however, contribute 1 ½% of the employee's base salary into a Retirement Health Savings account for those hired after January 1, 2013. I like to thank Attorney Mike Durkin and the Village's negotiation team of Administrator Belmonte, Finance Director Scarpiniti, Police Chief Garvey and Deputy Police Chief Niemann form their efforts in getting a CBA accomplished.

Next, **Trustee Hermanek moved, seconded** by **Trustee DeSantis,** to **authorize** the execution of a collective bargaining agreement between the Illinois Fraternal Order of Police Labor Council, North Riverside Telecommunications Unit and the Village of North Riverside and for Attorney to prepare the proper ordinance for passage.

This is a project that took months to accomplish and I like to thank Karyn Byrne and everyone who worked on these changes to update our codes."

- **Senior Drop-in** program meets every Tuesday from 10:00 a.m. to 12:30 p.m. Play Board games, cards, listen to special speakers on topics of interest, or just socialized with new friends.
- **Kids 4, on 4 Basketball Leagues,** began on March 14, 2013. The Junior High Players have been encouraged to manage their own teams with no parent involvement. Come

- The Riverside-Brookfield Pool: The North Riverside Recreation Department began registration for pool passes this past Sunday. The pool will open up to residents commencing Sunday, April 7, 2013, from 12:00 noon to 4:00 p.m. A pool pass will be required in order to enter the pool; therefore, residents are asked to stop in at the Recreation Department office to obtain one.
- The North Riverside Players production of Nunsense is scheduled for Saturday, March 23, 2013. Tickets are still available.
- As a **reminder**, the **Neighborhood Services meeting** is scheduled for Tuesday, March 19, 2013, at 7:30 p.m., in the Community Room.

MAYORAL REPORT:

Mayor Krochmal indicated that this meeting will be the last one before the Easter Holiday, and he wished all a happy one. Piper, in representation of Tom Bensfield, to Dr. Queenella Miller (Clerk), Mayor Krochmal and the Village Trustees, that stated, in essence, that the content of the related to the Application of the Illinois Saint Andrew Society for Variances and Amendment to Conditional Use Permit for the Scottish Home, which pointed out that there are numerous reasons why granting the relief sought is improper and in violation to the statutory requirements for granting variances and amendment to Conditional Use Permits...; therefore, the record is devoid of the statutory requirements that must exist before the Village can grant the zoning relief sought., etc...and it is premature for the Village to proceed tonight with the passage of an ordinance for the /Scottish Home when the legal prerequisites to adopt the ordinance do not exist. This may be an **exparte** finding.
