AN ORDINANCE AMENDING LICENSE FEES IN TITLE 10 “VEHICLES AND TRAFFIC”
OF THE VILLAGE OF NORTH RIVERSIDE MUNICIPAL CODE
IN THE VILLAGE OF NORTH RIVERSIDE,
COOK COUNTY, ILLINOIS

WHEREAS, the Village of North Riverside, Cook County, Illinois (the *AVillage@*) is a duly organized and existing municipal corporation created under the provisions of the laws of the State of Illinois and under the provisions of the Illinois Municipal Code, as from time to time supplemented and amended.

WHEREAS, the Village exercises the power to license the ownership and operation of motor vehicles in the Village;

WHEREAS, the Village has previously adopted a schedule of license fees and penalties, among other regulations, related to the issuance of licenses for the ownership and operation of motor vehicles in the Village;

WHEREAS, the Village is authorized to enforce the licensing requirements for motor vehicles, including establishing applicable fees and applying penalties, as provided for in the Village Code; and

WHEREAS, the President and the Board of Trustees have determined that it is in the best interests of the Village to amend the schedule of fees for motor vehicle licenses by adding license requirements and fees for the storage of motor vehicles within the Village and providing for the enforcement of violations.

NOW THEREFORE, be it ordained by the President and Board of Trustees of the Village of North Riverside, Cook County, Illinois as follows:

SECTION 1: RECITALS.

That the above recitals and legislative findings are found to be true and correct and are hereby incorporated herein and made a part hereof, as if fully set forth in their entirety.

SECTION 2: Subsections A. of Section 10.12.030, “*License fees*”, of Chapter 10.12, “*Vehicle Licensing*”, of Title 10, “*Vehicles and Traffic*”, of the North Riverside Municipal Code is hereby amended by deleting the following stricken language and adding the underlined language to read, as follows:

10.12.030 – License fees.

A. The license fees under this chapter to be paid annually to the village clerk for each vehicle shall be as follows:

Description	Fee
Automobiles/Noncommercial trucks	\$35.00 <u>50.00</u>
Commercial trucks	\$40.00 <u>80.00</u>
Motorcycles	\$15.00 <u>20.00</u>

SECTION 3: Subsections D. of Section 10.12.030, “*License fees*”, of Chapter 10.12, “*Vehicle Licensing*”, of Title 10, “*Vehicles and Traffic*”, of the North Riverside Municipal Code is hereby amended by deleting the following stricken language and adding the underlined language to read, as follows:

D. Delinquent Fees. In the event said vehicle license is not purchased by June 1st of each year, the fees for the license shall be as follows:

Description	Fee
Automobiles/Noncommercial trucks	\$70.00 <u>100.00</u>
Commercial trucks	\$80.00 <u>160.00</u>
Motorcycles	\$30.00 <u>40.00</u>
Vehicles (Age 65+)	\$20.00
Vehicles (Handicapped/Disabled)	\$20.00

SECTION 4: REPEALER.

All Ordinances or parts of Ordinances in conflict with any of the provisions of this Ordinance shall be, and the same are hereby repealed.

SECTION 5: SEVERABILITY.

This Ordinance, and every provision hereof, shall be considered severable. In the event that any court of competent jurisdiction may find and declare any word, phrase, clause, sentence, paragraph, provision or section or part of a phrase, clause, sentence, paragraph, provision or section of this Ordinance is void or unconstitutional, the remaining words, phrases, clauses, sentences, paragraphs and provisions and parts of phrases, clauses, sentences, paragraphs, provisions and sections not ruled void or unconstitutional shall continue in full force and effect.

SECTION 6: EFFECTIVE DATE.

This Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
