AN ORDINANCE AMENDING THE NORTH RIVERSIDE MUNICIPAL CODE  
REGARDING GARBAGE COLLECTION RATES  
IN THE VILLAGE OF NORTH RIVERSIDE,  
COOK COUNTY, ILLINOIS

WHEREAS, the Village of North Riverside, Cook County, Illinois (the “*Village*”) is a duly organized and existing municipal corporation created under the provisions of the laws of the State of Illinois and under the provisions of the Illinois Municipal Code, as from time to time supplemented and amended.

WHEREAS, the Village provides for the regular collection and disposal of waste for residents and businesses in the Village; and

WHEREAS, the Village President and Board of Trustees find it necessary to adjust from time to time the existing rates charged for such municipal service to meet the increasing costs to the Village of such waste collection and disposal services.

NOW THEREFORE, be it ordained by the President and Board of Trustees of the Village of North Riverside, Cook County, Illinois as follows:

**SECTION 1: RECITALS.**

That the above recitals and legislative findings are found to be true and correct and are hereby incorporated herein and made a part hereof, as if fully set forth in their entirety.

**SECTION 2:** Chapter 8.16 of the North Riverside Municipal Code, entitled “Garbage and Rubbish”, Section 8.16.160, entitled “Disposal-Rates-Penalties-Designated”, is amended by adding the underlined language to read, as follows:

**18.16.160 – Disposal—Rates—Penalties—Designated.**

Garbage rates for the collection and disposal of garbage and refuse shall be assessed against and billed in advance, with current water bills, to each resident user in the village on a bi-monthly basis. Bi-monthly rates are established as follows:

- A. For each family unit: forty-six dollars and seventy-five cents (\$46.75);
- B. Multiple-family units, commercial, industrial, or institutional establishments: to be established by the president and board of trustees upon application to the village clerk;
- C. In addition to all other remedies and rights provided in this chapter or otherwise, in the event any person, firm, or corporation does not deliver to the village payment in the amount billed by the village for the collection and disposal of garbage and refuse when due, such person, firm, or corporation shall be liable for and shall pay an additional amount of ten percent of the net amount of the bi-monthly bill not paid within twenty days of the date thereof.

**SECTION 3: REPEALER.**

All Ordinances or parts of Ordinances in conflict with any of the provisions of this Ordinance shall be, and the same are hereby repealed.

**SECTION 4: SEVERABILITY.**

This Ordinance, and every provision thereof, shall be considered severable. In the event that any court of competent jurisdiction may find and declare any word, phrase, clause, sentence, paragraph, provision or section or part of a phrase, clause, sentence, paragraph, provision or section of this Ordinance is void or unconstitutional, the remaining words, phrases, clauses, sentences, paragraphs and provisions and parts of phrases, clauses, sentences, paragraphs, provisions and sections not ruled void or unconstitutional shall continue in full force and effect.

**SECTION 5: EFFECTIVE DATE.**

This Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
