We want you to note on your calendar that registration is **NOW OPEN** for our **2017-2018 PRESCHOOL** programs. We will hold a spot for continuing families until January 27<sup>th</sup>.

A \$70.00 non-refundable deposit should be made at time of registration (this includes supply fee). In order to coincide with our fiscal year, the monthly preschool payments will be prepaid. Each payment should be made one month in advance, which means your first payment is due August 1st, and your final payment (for May) is due April 1<sup>st</sup>. NOTE: If you prepay the full year by August 1<sup>st</sup> you will receive a 5% discount off the annual total. We are very proud of our program -- the staff, the facilities, the equipment and materials we use, the special events for parents and families to interact with their child, etc. It is truly a quality experience for your child and a value to you as parents.
