Having submitted the plans and specifications, I hereby apply to the Building Department of Village of North Riverside, Illinois, for a permit to perform the above mentioned work. If this permit is granted I will comply with all the Village Ordinances relating to the permit and pay all fees required. I will submit this work to the required inspections and prohibit the occupancy of any space until a Certificate of Compliance and Occupancy has been obtained from the Building Commissioner. Work to begin within 30 days of issuance of permit. All work covered by the permit is to be completed within one year from date of permit.

No error or omission in either the plans or application, whether said plans or application have been approved by the Building Commissioner or not, shall permit or relieve the applicant from constructing the work in any other manner than that provided for in the Ordinance of this Village relating thereto. The applicant having read this application and fully understanding the intent thereof declares that the statements made are true to the best of my knowledge and belief.
