## **REPORT OF TRUSTEES**

## Trustee Bianco

Trustee Bianco read the following Request for Board Action:

Komarek School is nearing the completion of their campus renovation project, which was authorized by voters in March 2020. The school district requested the vacation of 13<sup>th</sup> Avenue by the Village for usage by the school. As a condition for the Village to vacate 13<sup>th</sup> Avenue between the two school buildings, School District 94 was required to upgrade and replace the watermain underneath from a 6" to 8" main at their cost. Last week, a portion of the watermain scheduled to be upgraded as part of this project developed a leak and required emergency repair. Due to the emergency repair needed, it was determined the pipe needed to be replaced should be upgraded at the same time to cost effective and minimize the service interruption to the school and residents serviced by watermain.

Komarek School has agreed to reimburse the Village for the total cost of the watermain replacement. This emergency purchase request will allow the Village to complete the emergency repair while still allowing the school district to finish their construction before the start of the school year. A formal agreement to vacate 13<sup>th</sup> Avenue will be prepared for passage ar a future Village board Meeting to authorize the project and reimbursement period, not to exceed five years. The contractor, Riccio Construction Corp, provided and emergency quote in an amount not to exceed \$168,105.00 to perform the work.

Riccio Construction Corporation is qualified to perform this work and is IDOT approved.

Trustee Bianco moved and Trustee Sarro seconded to authorize Riccio Construction Corporation to perform the 13<sup>th</sup> Avenue emergency watermain replacement in the total amount not to exceed \$177,000.00 including engineering and to waive the reading. Roll Call Vote:
