AN ORDINANCE ADOPTING SUPPLEMENTAL APPROPRIATIONS FOR FISCAL YEAR 2018-2019

WHEREAS, on July 23, 2018, the President and Board of Trustees approved Ordinance No. 18-O-09 entitled "Annual Appropriation Ordinance (2018-2019) for the Village of North Riverside, Illinois" ("2018-2019 Appropriation Ordinance"); and

WHEREAS, the President and Board of Trustees desire to amend the 2018-2019 Appropriation Ordinance and adopt supplemental appropriations in accordance with the terms of this Ordinance; and

WHEREAS, the Village Treasurer has informed the President and Board of Trustees that there is additional revenue available to the Village, or estimated to be received by the Village subsequent to July 23, 2018, which revenue was not available for appropriation when the 2018-2019 Appropriation Ordinance was passed and approved.

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of North Riverside, Illinois, as follows:

SECTION 1: The 2018-2019 Appropriation Ordinance is hereby amended as follows:

- A. As to those line items specifically listed in "Exhibit A" attached hereto and made a part hereof, the amounts appropriated in the 2018-2019 Appropriation Ordinance are hereby deleted, and substituted therefore are the amounts listed on the attached "Exhibit A".
- B. As to those line items for which no amount was appropriated, the sums set forth in "Exhibit A" for said line items are hereby added.

SECTION 2: The 2018-2019 Appropriation Ordinance is further amended in that the total current expenditure figures or summary figures are increased in the amounts necessary to correspond with the new amounts appropriated as listed on "Exhibit A" attached hereto.

SECTION 3: The amounts set forth in the column entitled "Amended Appropriation" on the attached "Exhibit A" are hereby appropriated for the fiscal year beginning May 1, 2018, and ending April 30, 2019. Said amounts are deemed necessary to defray necessary expenses and liabilities of the Village for said period.

SECTION 4: All Ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SECTION 5: If any term or provision of this Ordinance shall be invalid or unenforceable, the remainder of this Ordinance shall not be affected thereby, and the terms and provisions of this Ordinance shall be valid and be enforced to the fullest extent permitted by law.

SECTION 6: This Ordinance shall be in full force and effect from and after its passage, approval and publication as provided by laws.
