A RESOLUTION AUTHORIZING THE ADOPTION AND EXECUTION OF AN INTERGOVERNMENTAL AGREEMENT AMONG RIVERSIDE, BROOKFIELD, AND THE VILLAGE OF NORTH RIVERSIDE FOR USE OF THE NORTH RIVERSIDE POLICE DEPARTMENT HOLDING FACILITY IN THE VILLAGE OF NORTH RIVERSIDE, COOK COUNTY, ILLINOIS

WHEREAS the Village of North Riverside, Illinois (“Village”) is a duly organized municipal corporation under the laws of the State of Illinois;

WHEREAS, the Village is empowered under the Illinois Constitution and the Intergovernmental Cooperation Act (5 ILCS 220/3) to enter into intergovernmental agreements with other public agencies and districts on matters of mutual concern and interest such as the provision and sharing of adequate law enforcement resources for the protection of residents and property falling within the jurisdiction of the Village;

WHEREAS, the Village actively participates in various mutual aid agreements with neighboring police agencies, shares or combines various resources and services, including emergency dispatch services, and otherwise maintains professional relationships with neighboring agencies to promote public safety and security in the Village, neighboring districts, and the region;

WHEREAS, for exchanged mutual considerations, the Village wishes to enter into an intergovernmental agreement with the Villages of Riverside and Brookfield to allow their police departments to have access to and use of the Village’s police department holding facility to temporarily house their department’s arrestees; and

WHEREAS, the Village has received a proposed intergovernmental agreement for review by its officials that delineates the rights and responsibilities among the three agencies for use of the Village holding facility, including the fees and other compensation to be paid to the Village for the same.

NOW THEREFORE, be it resolved by the President and Board of Trustees of the Village of North Riverside, Cook County, Illinois as follows:

SECTION 1:

That the above recitals and legislative findings are found to be true and correct and are hereby incorporated herein and made a part hereof as if fully set forth in their entirety.

SECTION 2:

The Village Board hereby approves and accepts the Intergovernmental Agreement among the Villages of Riverside, Brookfield, and North Riverside substantially in the same form as the draft attached hereto as Exhibit A.

SECTION 3:

The Village President and Clerk or their designee are hereby authorized and directed to sign and execute, on behalf of the Village of North Riverside, the Agreement, in substantially the form contained in Exhibit A, and thereby enter into an Intergovernmental Agreement with the Villages of Riverside and Brookfield.

SECTION 4:

Thereafter, Village officials, officers, or employees, including the Chief of Police or her designee, are hereby authorized to the extent permitted by law, to take any action authorized in the Agreement according to its terms.

SECTION 5:

If any section, paragraph, clause or provision of this Resolution shall be held invalid it shall not affect any of the remaining provisions of this Resolution.

SECTION 6:

This Resolution shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
