You must meet the following minimum requirements:

- **Citizenship:** Must be a U.S. Citizen or legally authorized to work in the U.S. and provide evidence of intention to become a U.S. Citizen.
- **Driver's License:** Must have a valid IL driver's license or the ability to obtain one upon hiring
- **Age Requirements:** Applicants must have attained their 21st birthday by 7/15/20. Must be under the age of 35 on day of testing (8/1/20), and at such time as the Final Eligibility List is posted, unless exempt from such age limitations as provided in Section 5/0-1-7 and 5/10-1-12 of the Civil Service Act.
- **Education:** Must have a High School Diploma or equivalent (GED)
- **Character:** Must have no felony convictions and be of good moral character
- **Testing:** Must be able to participate and successfully complete all stages of the testing process.
- **Residency:** No residency requirements
- **Certification:** Must be certified by the office of the Illinois State Fire Marshal as a Basic Operations Firefighter or Firefighter II. Must also, be certified as an **EMT-P**, at the time of application and at the time of appointment.
- **CPAT CARD with Ladder Climb is REQUIRED: Must have a valid CPAT Card with Ladder Climb, issued between the dates of 4/15/2019 and 7/15/2020**
